City of Culver City Argument In Favor Of Measure #2 (Letter to be Designated)

(For Charter Amendment):

VOTE YES ON MEASURE ____

The California Voter Participation Rights Act was designed to increase voter participation by requiring cities to conduct local elections at the same time as statewide elections. Measure ____ complies with the Act by amending the city charter to move our local elections for members of the City Council to November of even numbered years—the same time as state and national general elections.

Measure ____ will:

- Help the city save money by holding elections at the same time;
- Dramatically increase voter turnout in our local elections;
- Advance the constitutional right to vote and the integrity of the electoral process;
- Increase the participation of groups that are underrepresented in low turnout elections; and
- Engage young voters in local elections.


If we do not vote to align our local elections with statewide elections, a court might order us to do it anyway, without your input and with the City paying all the legal fees.
