




U.S. imprisonment rate per 100,000 people since 1880










The Data

In 2018, MDH submitted a Public Records Act request to CCPD. CCPD provided 22 categories of data for 5,100 individual arrests made by CCPD between January 2016 and July 2018.


Data categories: name, age, place of arrest, time of arrest, gender, race, home zip code, charges, charge category


Charge Levels: Misdemeanor/Felony




Arrests by Gender




Arrests By Age




Racial Breakdown of CCPD Arrests




Arrests by Residence




Racial Breakdown: Arrests of CC Residents vs Overall CC Population


Most arrests in Culver City are for misdemeanor offenses

CCPD disproportionately arrests Black and Latinx residents of Culver City


CCPD most disproportionately arrests Black non-residents on Culver City




Proportion of Arrests at Westfield Mall




Driving on Suspended License - Charge Level



Single Charge - Driving on Suspended License Charge




Breakdown of Top Charges by Race

Collateral Consequences: Driving on a Suspended License in Los Angeles County

IF YOU ARE NOT A CITIZEN, YOU ARE HEREBY ADVISED THAT A CONVICTION OF THE OFFENSE FOR WHICH YOU HAVE BEEN CHARGED WILL HAVE THE CONSEQUENCES OF DEPORTATION, EXCLUSION FROM ADMISSION TO THE UNITED STATES, OR DENIAL OF NATURALIZATION PURSUANT TO THE LAWS OF THE UNITED STATES.

COURT FINDS THAT EACH SUCH WAIVER IS KNOWINGLY, UNDERSTANDINGLY, AND EXPLICITLY MADE;

DEFENDANT PLEADS GUILTY TO COUNT 01, 484(A) PC.

DEFENDANT GIVEN TOTAL CREDIT FOR 1 DAYS IN CUSTODY 1 DAYS ACTUAL CUSTODY AND

PAY A FINE OF \$300.00

PLUS A STATE PENALTY FUND ASSESSMENT OF \$870.00

PLUS \$1.00 NIGHT COURT.

PLUS \$60.00 CRIMINAL FINE SURCHARGE (PURSUANT TO 1465.7 P.C.)

\$40.00 COURT OPERATIONS ASSESSMENT (PURSUANT TO 1465.8(A)(1) P.C.)

\$30.00 CRIMINAL CONVICTION ASSESSMENT (PURSUANT TO 70373 G.C.)

\$4.00 EMERGENCY MEDICAL AIR TRANSPORTATION ACT FUND PER 76000.10(C)(1) GC

\$10.00 CITATION PROCESSING FEE (PURSUANT TO 1463.07 P.C.)

\$15.00 WARRANT ASSESSMENT (40508.5(A)V.C./853.7A(A)P.C.)

DEFENDANT TO PAY FINE TO THE COURT CLERK

IN LIEU OF FINE, DEFENDANT MAY:

PERFORM 10 DAYS OF COMMUNITY SERVICE

DEFENDANT TO PAY COURT COST OF \$30 .

DEFENDANT SHALL PAY A RESTITUTION FINE IN THE AMOUNT OF \$120.00 TO THE COURT

TOTAL DUE: \$1,480.00

IN ADDITION:

-DO NOT DRIVE A MOTOR VEHICLE WITHOUT A VALID DRIVER'S LICENSE IN YOUR POSSESSION OR WITHOUT LIABILITY INSURANCE IN AT LEAST THE MINIMUM AMOUNTS REQUIRED BY LAW.

-OBEY ALL LAWS AND ORDERS OF THE COURT.

-DEFENDANT IS ORDERED TO PAY A PROBATION REVOCATION RESTITUTION

FINE PURSUANT TO PENAL CODE SECTION 1202.44, IN THE AMOUNT OF \$ 120.00. THIS FINE SHALL BECOME EFFECTIVE UPON THE REVOCATION OF PROBATION.

Conclusions

Black people are the most disproportionately impacted by policing in Culver City, especially youth and non-residents. Latinx residents also experience a significant disparity in arrests.

Misdemeanors comprise the majority of arrest charges but even low-level charges and their collateral consequences negatively impact the conditions of life, disproportionately Black life.
