




### **GENERAL NOTES**

- . VERIFICATION: VERIFY SITE INFORMATION, INCLUDING PROPERTY LINES, LIMITS OF WORK, EASEMENTS, BUILDINGS, ROADWAY CURB AND/OR GUTTERS, UTILITIES, DUCT BANKS, AND OTHER INFORMATION THAT MAY AFFECT THE SCOPE OF WORK INCLUDED ON THESE DRAWINGS. CONTRACTOR SHALL CONTACT THE LANDSCAPE ARCHITECT FOR DIRECTION ON HOW TO PROCEED IF ACTUAL SITE CONDITIONS VARY FROM WHAT IS SHOWN ON THE DRAWINGS.
- 2. DESIGN INTENT: THESE DRAWINGS REPRESENT THE GENERAL DESIGN INTENT TO BE IMPLEMENTED ON THE SITE. CONTRACTOR SHALL BE RESPONSIBLE FOR CONTACTING OWNER FOR ANY ADDITIONAL CLARIFICATION OR DETAILS NECESSARY TO ACCOMMODATE SITE CONDITIONS OR ARCHITECTURAL DETAILS.
- 3. CONTRACTOR COORDINATION: CONTRACTOR SHALL BE RESPONSIBLE FOR COORDINATION WITH IMPROVEMENTS SHOWN IN THE REDESIGN. EACH CONTRACTOR SHALL COORDINATE AND OTHERWISE INTEGRATE WORK WITH THAT OF OTHERS IN AN EFFICIENT AND TIMELY MANNER SO AS TO PROVIDE THE OWNER WITH A WELL-CONSTRUCTED, EASILY MAINTAINABLE PROJECT. EACH CONTRACTOR SHALL NOTIFY OTHERS AT LEAST TWO WORKING DAYS IN ADVANCE OF COVERING, COMPLETING, OR EXPOSING WORK TO BE INSTALLED BY OTHERS.
- 4. CONTRACTORS' JOB SITE CONDITIONS: CONTRACTOR AGREES TO ASSUME SOLE AND COMPLETE RESPONSIBILITY FOR SITE CONDITIONS DURING CONSTRUCTION, INCLUDING SAFETY OF ALL PERSONS AND 6. REMOVAL OF LANDSCAPING SHALL INCLUDE ROOTS AND ORGANIC MATERIALS. PROPERTY; THAT THIS REQUIREMENT SHALL APPLY CONTINUOUSLY AND NOT BE LIMITED TO NORMAL WORKING HOURS; AND THAT THE CONTRACTOR SHALL DEFEND, INDEMNIFY, AND HOLD THE OWNER, RTI CONSULTING, AND THE LANDSCAPE ARCHITECT HARMLESS FROM ANY AND ALL LIABILITY, REAL OR ALLEGED. IN CONNECTION WITH THE PERFORMANCE OF WORK ON THIS PROJECT. EXCEPTING FOR LIABILITY ARISING FROM THE SOLE NEGLIGENCE OF THE OWNER OR THE LANDSCAPE ARCHITECT.
- 5. AREA OF DISTURBANCE: LIMIT USE OF PREMISES TO WORK IN AREAS AS INDICATED. DO NOT DISTURB PORTIONS OF THE SITE BEYOND AREAS IN WHICH WORK IS INDICATED. KEEP DRIVEWAYS AND ENTRANCES SERVING PREMISES CLEAR AND AVAILABLE TO THE OWNER AND EMERGENCY VEHICLES AT ALL TIMES. DO NOT USE THESE AREAS FOR PARKING OR STORAGE OF MATERIALS. SCHEDULE DELIVERIES TO MINIMIZE USE OF DRIVEWAYS AND ENTRANCES.
- 6. EXISTING UTILITIES: A REASONABLE EFFORT HAS BEEN MADE TO LOCATE AND DELINEATE ALL KNOWN UNDERGROUND UTILITIES. THE CONTRACTOR IS CAUTIONED THAT ONLY EXCAVATION WILL REVEAL THE TYPES, EXTENT, SIZES, LOCATION, AND DEPTHS OF SUCH UNDERGROUND UTILITIES. HOWEVER, THE CONSULTANT CAN ASSUME NO RESPONSIBILITY FOR THE COMPLETENESS OR ACCURACY OF ITS DELINEATION OF SUCH UNDERGROUND UTILITIES, NOR FOR THE EXISTENCE OF OTHER BURIED OBJECTS OR UTILITIES WHICH ARE NOT SHOWN ON THESE DRAWINGS. - 7. TREE PROTECTION AND MAINTENANCE REQUIREMENTS: ALL TRENCHING WITHIN THE DRIPLINE OF EXISTING TREES TO REMAIN SHALL BE BY HAND, WITH CARE TAKEN NOT TO CUT OR DAMAGE ROOTS OVER ONE INCH IN DIAMETER. TREES TO REMAIN SHALL BE FENCED PER TEMPORARY TREE AND PLANT PROTECTION SPECIFICATIONS.
- 8. CONFLICTS: WHERE PLANS AND/OR SPECIFICATIONS ARE FOUND TO BE IN CONFLICT, OR WHERE VARIOUS ITEMS OF WORK ARE SEEN TO BE IN CONFLICT, IMMEDIATELY NOTIFY THE OWNER AND/OR LANDSCAPE ARCHITECT FOR DIRECTION PRIOR TO PROCEEDING WITH WORK.
- 9. UNAUTHORIZED CHANGES AND USES: ALL PROPOSED CHANGES TO THE PLANS MUST BE BROUGHT TO THE ATTENTION OF THE LANDSCAPE ARCHITECT IN WRITING AND MUST BE APPROVED BY THE LANDSCAPE ARCHITECT IN ADVANCE.
- 10. DESIGN CONSULTANT ADVISORY: ADVISE CONSTRUCTION AND OPERATIONS WITH THE PROJECT'S DESIGN CONSULTANTS FOR WORK INDICATED HEREIN. INFORM THE OWNER AND THE LANDSCAPE ARCHITECT ON THE PREFERRED CONSTRUCTION SCHEDULE PRIOR TO THE WORK BEING PERFORMED. ADJUST CONSTRUCTION SCHEDULE ACCORDINGLY BASED ON A MUTUALLY-AGREEABLE TIMETABLE. NOTIFY THE OWNER AND THE LANDSCAPE ARCHITECT IF CHANGE TO CONSTRUCTION SCHEDULE IS REQUIRED DUE TO DIFFERENCES IN ACTUAL CONSTRUCTION PROGRESS. INCLUDE THE PROJECT'S DESIGN CONSULTANTS AT PRE-INSTALLATION MEETINGS COVERING PORTIONS OF THE WORK THAT ARE RELATED. NOTIFY THE OWNER AND THE LANDSCAPE ARCHITECT IF CHANGES TO CONSTRUCTION SCHEDULE ARE REQUIRED DUE TO DIFFERENCES IN ACTUAL CONSTRUCTION PROGRESS.
- 12. CLEARING AND GRUBBING: CONTRACTOR SHALL CLEAR AND GRUB ALL EXISTING VEGETATION UNLESS OTHERWISE INDICATED. AS REQUIRED FOR SITE CONSTRUCTION, IRRIGATION AND PLANTING OPERATIONS. PRIOR TO COMMENCEMENT OF WORK, LIMIT OF CLEARING SHALL BE REVIEWED BY OWNER AND THE LANDSCAPE ARCHITECT. STRIP ALL ORGANIC MATTER TO A SUFFICIENT DEPTH TO COMPLETELY REMOVE SUCH MATERIAL.
- 13. CLEAN UP: CONTRACTOR SHALL REMOVE LITTER AND DEBRIS FROM THE PROJECT SITE AS REQUIRED TO KEEP SITE IN AN ORDERLY FASHION. DUST CONTROL MEASURES SHALL BE EXERCISED.
- 14. CONTRACTOR TO COORDINATE WITH OWNER REGARDING ALL SALVAGEABLE MATERIALS, INCLUDING BUT NOT LIMITED TO UTILITIES, FURNISHINGS, AND PLANTING POTS.
- 15. CONTRACTOR UNDERSTANDS THAT TIME IS OF THE ESSENCE AND THAT WHEN SELECTING A CONTRACTOR, THE CITY WILL CONSIDER THE AMOUNT OF TIME THEY WILL TAKE TO COMPLETE THE CONSTRUCTION. CONTRACTOR UNDERSTANDS AND AGREES THAT THE CITY INTENDS TO HOLD CONTRACTOR ACCOUNTABLE TO THE SCHEDULE THEY PROPOSE IN THEIR BID. WHICH MAY TAKE THE FORM OF IMPOSING A FINANCIAL PENALTY FOR EACH DAY THE CONTRACTOR DELAYS COMPLETION OF THE CONSTRUCTION, PROVIDED THE CAUSE OF THE DELAY IS WITHIN THE CONTROL OF THE CONTRACTOR.

### GENERAL DEMOLITION NOTES:

- 1. CONTRACTOR TO CLEAR PROJECT SITE AREA WITHIN THE CONFINES OF THE LIMIT OF WORK LINE. THE CONTRACTOR SHALL DEMOLISH AND REMOVE FROM THE SITE ALL EXISTING PLANTERS. PLANTINGS, AND OTHER SITE FEATURES, EXISTING ROOTS AND ORGANIC MATERIAL IS TO BE CLEARED AND GRUBBED. REFER TO SPECIFICATIONS FOR ADDITIONAL REQUIREMENTS.
- 2. DEMOLITION AND REMOVAL OF PAVEMENT INCLUDES THICKNESS AS WELL AS BASE COURSE THICKNESS. DEMOLITION AND REMOVAL OF WALLS INCLUDES THICKNESS AS WELL AS FOUNDATIONS, FOOTINGS, AND BASE COURSE THICKNESS.
- 3. EXISTING IRRIGATION CONTROLLERS TO BE PRESERVED .ALL REMOVED SPRAY AND AND BUBBLER HEADS TO BE PRESERVED AND RETURNED TO THE CITY PARKS DEPAREMENT.
- 4. PLANTING AREAS OUTSIDE OF SCOPE OF WORK, ON (E) IRRIGATION SYSTEM, ARE TO BE MAINTAINED WITH TEMPORARY AUTOMATIC IRRIGATION SYSTEM UNTIL RECONNECTED TO NEW SYSTEM
- 5. USE PVC SCHEDULE 80 AS SLEEVING, 2 TIMES THE DIAMETER OF PIPE OR WIRE BUNDLE CARRIED PLACED BELOW ALL PAVING, HARDSCAPE, ETC. AND AS DIRECTED BY OWNER'S AUTHORIZED REPRESENTATIVE.
- 7. THE CONTRACTOR SHALL BE RESPONSIBLE FOR OBTAINING ANY AND ALL PERMITS AND SHALL PAY ALL FEES NECESSARY FOR ENCROACHMENT, GRADING, DEMOLITION, AND DISPOSAL OF SAID MATERIALS AS REQUIRED BY PRIVATE, LOCAL, AND STATE JURISDICTIONS. CULVER CITY DOES NOT CHARGE A FEE TO ISSUE PERMITS THAT ARE ENTIRELY UNDER ITS PURVIEW FOR ITS OWN PROJECT.
- 8. THE CONTRACTOR SHALL BE RESPONSIBLE FOR A SITE INSPECTION TO FULLY ACKNOWLEDGE THE EXTENT OF DEMOLITION WORK.
- 9. THE CONTRACTOR SHALL VERIFY AND LOCATE ALL EXISTING ABOVE AND UNDERGROUND UTILITIES LOCATIONS SHOWN ON THE PLANS ARE APPROXIMATE AND ARE SHOWN FOR GENERAL INFORMATION
- 10. DAMAGE TO ANY EXISTING UTILITIES AND SERVICES TO REMAIN SHALL BE THE RESPONSIBILITY OF THE CONTRACTOR. CONTRACTOR SHALL REPAIR AND/OR REPLACE IN KIND.
- 11. EROSION CONTROL MEASURES SHALL BE PRIOR TO DEMOLITION ACTIVITIES TO PREVENT DEBRIS AND UNSUITABLE MATERIALS FROM ENTERING STORM DRAINS, SANITARY SEWERS AND STREETS. SEE EROSION CONTROL PLAN.
- 12. CITY REFUSE COLLECTION IS EXCLUSIVE. CONTRACTOR SHALL CONTACT THE ENVIRONMENTAL PROGRAMS AND OPERATIONS DIVISION OF PUBLIC WORKS DEPARTMENT OF THE CITY TO ARRANGE FOR DEMOLITION MATERIAL REMOVAL AND RECYCLING FROM THE SITE AS WORK PROGRESSES.
- 13. THE DRAWINGS MAY NOT INDICATE IN DETAIL ALL DEMOLITION WORK TO BE PERFORMED. THE CONTRACTOR SHALL EXAMINE EXISTING CONDITIONS TO DETERMINE THE FULL EXTENT OF DEMOLITION.
- 14. ALL DEMOLITION SHALL COMPLY WITH CHAPTER 24A AND ARTICLE 87 OF THE CALIFORNIA FIRE
- 15. CONTRACTOR TO USE CARE IN HANDLING DEBRIS FROM SITE TO ENSURE THE SAFETY OF THE PUBLIC. HAUL ROUTE TO BE CLOSELY MONITORED FOR DEBRIS OR MATERIAL TRACKED ONTO ADJOINING ROADWAYS, SIDEWALKS, ETC. ROADWAYS AND WALKWAYS TO BE CLEARED DAILY OR AS NECESSARY YO MAINTAIN PUBLIC SAFETY.
- 16. CONTRACTOR TO INSTALL CHAIN LINK FENCE WITH MESH SCREEN TO PROTECT PUBLIC FROM ENTERING CONSTRUCTION AREA.
- 17. DUST CONTROL SHALL BE IMPLEMENTED DURING DEMOLITION.
- 18. DEMOLITION IS LIMITED TO WITHIN LIMIT OF WORK LINE UNLESS NOTED OTHERWISE.
- 19. THE CONTRACTOR SHALL VERIFY THE LOCATION AND QUANTITY OF EXISTING SURFACE STRUCTURES AND SHALL BE SOLELY RESPONSIBLE FOR ANY UNIDENTIFIED UTILITIES. IMPROVEMENTS. TREES. ETC. TO BE DEMOLISHED AND REMOVED WITHIN THE LIMIT OF WORK LINE, INCLUDING APPURTENANT FOUNDATIONS OR SUPPORTS.
- 20. DEMOLITION CALLOUTS IN THIS PLAN ARE REPRESENTATIVE OF WHAT IS TO BE DONE, NOT AN ITEMIZED ACCOUNTING FOR EACH ELEMENT OR FEATURE THAT IS TO BE DEMOLISHED, REMOVED, AND DISPOSED OF.
- 21. PRIOR TO COMMENCING CONSTRUCTION CONTRACTOR SHALL HOST A CONSTRUCTION KICK-OFF MEETING WITH CULVER CITY REPRESENTATIVE AND LANDSCAPE ARCHITECT TO CONFIRM LIMITS OF
- 22. PROTECT IN PLACE ALL UTILITIES, UTILITY LINES AND SLEEVES UNLESS OTHERWISE NOTED.
- 23. ALL SURFACE UTILITY FEATURES ARE TO BE ADJUSTED TO NEW GRADE AS REQUIRED.






