**The following work requires plan review, check all that apply:**

- ☐ New or altered commercial kitchen
- ☐ Work floor area is 5,000 square feet or more
- ☐ Non-residential work floor area over 1,000 square feet and alters 10% or more of existing lighting fixtures
- ☐ Construction of new multi-family or mixed-use building with 4 or more residential units
- ☐ Work that requires energy code compliance forms (such as lighting or electrical distribution)
- ☐ Installing a 400 Amps or greater service panel
- ☐ Installing equipment rated 600 Volts or more
- ☐ Installing a transformer rated 112.5 kVA or more
- ☐ Installing a solar photovoltaic (PV) system or an energy storage system (ESS)
- ☐ Installing or altering a telecommunication/cellular site
- ☐ Cannabis related project

**Plan review procedure:**

- Submit two sets of electrical plans, with a complete Electrical Permit Application
- Plan reviews may require architectural drawings for reference
- Plan reviews will take approximately 15 to 20 business days
