## PRE-ELECTION DAY PROCESSING AND CANVASSING

For Vote by Mail ballots received prior to or on Election Day:

Pursuant to Elections Code Section 15101(a) the Processing of Vote by Mail ballot return envelopes (verification of signature and address and updating voter records) may begin 29 days before the election, and thus will commence at 7:30 AM on Monday, July 28, 2025 in the Louis Armstrong Conference Room, located at City Hall, First Floor, 9770 Culver Blvd, Culver City, CA 90232. Vote by Mail ballot return envelopes processing may occur daily thereafter between 7:30 AM and 5:30 PM.

Pursuant to Elections Code Section 15101(b) the Pre-Election Canvassing of Vote by Mail ballots (opening the returned vote by mail ballot envelopes, removing the ballots, accurately duplicating any damaged or defective ballots, and preparing the ballots for the ballot count) may begin the 29th day before the election, and thus may commence at 8:00 PM on Monday, July 28, 2025 in the Mike Balkman Council Chambers, located at City Hall, First Floor, 9770 Culver Blvd, Culver City, CA 90232.

The Count of the Vote by Mail ballots (those received on or prior to election day and have been processed and canvassed as described above) will commence after the close of the election at 8:00 PM on Tuesday, August 26, 2025 at City Hall in the Mike Balkman Council Chambers located at:

## POST-ELECTION DAY PROCESSING AND CANVASSING

For Vote by Mail ballots received on Election Day and Vote by Mail ballots received up to seven (7) days following the election, with postmarks on or before election day:

The post-election day Processing of Vote by Mail ballot return envelopes (verification of signature and updating voter records) and the Canvassing of Vote by Mail ballots (opening the returned vote by mail ballot envelopes, removing the ballots, accurately duplicating any damaged or defective ballots, and preparing the ballots for the ballot count) will begin at or after 7:30 AM on Wednesday, August 27, 2025 at City Hall. To

determine if ballot envelope processing or canvassing will take place on a particular day, please call (310) 253-5851.

The post-election day Count of the 2<sup>nd</sup> batch of Vote by Mail ballots will commence at approximately 11:00 AM on Thursday, September 4, 2025 at City Hall in the Mike Balkman Council Chambers.
